Guidelines and Indications by the organizer for the annual “Westricher Fastnachtsumzug”

By observing the following guidelines and indications you contribute to the secure and smooth course of the parade!

1. Line-up

- The line-up starts at 12pm in the “August-Süßdorf-Straße” (address for navigation system: August-Süßdorf-Straße 5). To reach that street you have to drive through “Stutzenflur”. So, you need to take the street across Autohaus Lessmeister (Steinwendener Straße 35). Therefore, you need to turn left right before Edeka. The parade also finishes in the “August-Süßdorf-Straße”.
- The vehicles have to be parked on the left side of the street!
- The positions regarding the line-up have to be kept during the parade!
- Loading and unloading of vehicles as well as getting into/on or out of the vehicles is strictly forbidden in “Bahnhofstraße”! It has to take place in August-Süßdorf-Straße!

2. Parade’s route

- The parade tours the following streets:
 - August-Süßdorf-Straße (start and line-up), Bahnhofstraße, Schulstraße, Landstuhler Straße, Jahnstraße, Siedlungstraße, Lilienstraße, Spesbacher Straße, Miesenbacher Straße, Bahnhofstraße, August-Süßdorf-Straße (end and termination).
- The organizer reserves the right to reduce the parade’s route due to very bad weather conditions! The contact person will be informed about the changes.

3. General information

- You are forced to follow the instructions of the organizer, the police, public order office (“Ordnungsamt”), the fire fighters and emergency personnel!
- The drivers including the front passenger, regulator and guards are forbidden to be under the influence of alcohol and drugs!
- To hand over drinks to the spectators out of and down from the vehicles is forbidden!
- The giveaways have to be thrown out at the side of the vehicle! It is **strictly forbidden** to throw them in front of and behind the vehicles as well as to hand over giveaways directly out of the vehicle!
- The giveaways whose use-by date is expired are not allowed!
- Empty bottles, cardboards, packaging materials and similar products remain by the participants (especially on vehicles) and are not allowed to be thrown away at the line-up and course of the parade!
- All participants are asked to behave in an appropriate manner!

- The groups are pleased to stay in visual contact with the preceding group in order to avoid delays! To prevent gaps within the parade dance performances, concerts and other performances are only allowed at the “Museum im Westrich” (Miesenbacher Straße)!
- During the parade you have to maintain a safety distance of 10 meters to the preceding group!

4. Vehicles

- Relevant regulations of the German *Straßenverkehrsrecht* (StVZO and StVO) are validated for all vehicles driving on public roads!
- During the drive to and the departure from the “August-Süßdorf-Straße” all traffic regulations have to be followed!
 - The organizer assumes no liability during the starting and departure!
- The driver needs to have a valid driver’s license and is forbidden to be under the influence of alcohol and drugs!
- **The following applies and you are obliged to follow it: “Erlass des Ministeriums für Wirtschaft, Verkehr, Landwirtschaft und Weinbau im Sinne einer Zusammenfassung der Rechtslage und von Empfehlungen zum Einsatz von Fahrzeugen und Fahrzeugkombinationen bei örtlichen Brauchtumsveranstaltungen (einschließlich Felder- und Weinbergsfahrten) in Rheinland-Pfalz vom 22. Oktober 2018“!** (see appendix)
 - A *Kraftfahrzeughaftpflichtversicherung* must exist for every used vehicle (tractor and trailer).
 - Every vehicle that is not registered needs to have a temporary registration plate according to §16a FZV. Red registration plates are not allowed!
 - Vehicles and trailers must have an operating license and must be roadworthy!
 - The road safety from vehicles and vehicle combinations has to be certified by a registered inspector for the motor traffic or rather a registered inspector from a technical service in an expert report about the equipment and functioning of vehicles and vehicle combinations for the use in traditional events (compare: §1 Abs. 1a Satz 2, 2. AusnahmeVO).
 - At least one copy of the expert report has to be carried along on the event day!
 - If it is not possible to get an expert opinion earlier than the event day, there is the opportunity to generate an expert opinion on that day. In terms of organization, please contact Volker Lang until 10th January 2020 (mobile: 0163-6025016 or mail: umzug@kvbruchkatze.de)!
 - The expert opinion is valid for a maximum of 24 months, as long as there are no significant changes on the vehicles!
 - During traditional events you are obliged to move with walking pace (4-7 km/h) (compare: §1 Abs. 4, Nr. 2, 2. Halbsatz, 2. AusnahmeVO).
- To avoid that people can move up to the vehicles, every vehicle has to be accompanied by security staff according to its type and length. The following security staff is required on each side of the vehicle:

○ car	1 person
○ car with trailer	3 persons (1 next to the drawbar)
○ pickup truck/van/something similar	2 persons
○ pickup truck/van/something similar with trailer	3 persons
○ truck without trailer	3 persons
○ truck with trailer or low-loader, tractor with trailer or low-loader	5 persons

- The security staff has to be clearly recognizable (e.g. through a warning vest), at least 16 years old, physically capable and is **not** allowed to be under the influence of alcohol and drugs!
- The trucks are required to be technically and personally secured that the danger of the audience and other persons is expelled!
 - Because of the risk of rolling over it is required to secure all wheels of the vehicles as low as possible, but at least 30 centimeters from the ground!
 - Benches, tables and other constructions/installations are required to be firmly attached to the vehicle! The connections have to resist the ordinary mechanical stress from vehicles while being in service!
 - When persons are carried in a sitting position on the vehicles, they have to be equipped with a slip-resistant and secure standing area/ground, holding devices, railings or rather balustrades as well as entries and exists!
 - When persons are carried in a standing position, balustrades or rather railings with a minimum height of 1 meter are required!
- It is not allowed to exceed the permissible gross weight including the persons and loaded objects/materials!

5. Liability

- You are obliged to respect the legal and official requirements as well as regulations!
- The persons who are responsible for the single groups are obliged to inform and educate all participants about the whole guidelines and indications. They are also responsible to supervise that the guidelines are adhered/followed!
- The *Karnevalverein "Bruchkatze" e.V. Ramstein* is responsible for the *Veranstaltungshaftpflichtversicherung*!
- The vehicle owner/driver is responsible for the vehicle insurance and the *KFZ-Haftpflichtversicherung* (tractor and trailer)!
- The driver and owner of the vehicle are responsible for possible damages on the vehicle!
